## TRADE STALL HOLDERS RULES & REGULATIONS

- 1. Temora Show Society Inc. will ensure that all care is taken, but no responsibility will be taken for damage or loss however caused to any equipment, displays or stalls.
- 2. Temora Show Society Inc. reserves the right to reject any application at its sole discretion the decision in this regard shall be final.
- 3. The placement of stalls is at the sole discretion of the Temora Show Society Inc however applicants site preference will be considered.
- 4. Entry to the Ground Space will ONLY be from the double gates on Airport Street between 8am and 6:00pm on Thursday or Friday of the week of the show and from 6am to 9am on Show Day.
- 5. All displays, stalls, etc. must be in position by I 0.00 am Saturday morning, and must remain until 6pm.
- 6. Leaving before 6 pm on Saturday night without prior consent from the Ground Space may result in forfeiture of a site next year.
- 7. Political advertising is not allowed. Exhibitors must confine their business to that stated on their application form. No subletting is permitted. Hawking, Selling, Canvassing or distributing prior matter is not permitted outside the area allocated, unless approval is applied for by the executive granted by Temora Show Society Inc.
- 8. Temora Show Society Inc reserves the right to have removed any item it considers objectable or dangerous which is offered to patrons for sale, display or as a prize given or distributed.
- 9. Exhibitors and or their employees are to conduct themselves in an orderly and respectful manner within the showground.
- 10. Power is very limited and stall holders are responsible for supplying their own power and leads stands, special lighting etc. and the removal of the same. All leads must be tagged.
- 11. All vehicles must be removed from the Ground Space area by 9.00 am on the day of the show.
- 12. The following items are not to be sold by Itinerants: Fairy Floss, Dagwood Dogs, Waffles, Doughnuts, Snow Cones, Toffee Apples, Drug Related Goods (including cocaine kits, bong explicit and hard core T-Shirts, Fake Cigarettes, Fireworks or Crackers, Fuel type Fire Lighters Horns or Trumpets, Knives (including Pen Knives), Laser Pointers, Metal and Wooden Martial Nunchakus, Playing Cards (Nude or Lurid), Pressure Pack Snow, Silly String or Stink Bombs.

\*\*\* All animals must be on a leash or a chain.
